- c. Discount for growers who produce 100% of what they sell (see Rules & Regulations).

\_\_\_\_\_ **Week-to-Week Vendor** - Price for 10' wide booth is \$15 per regular market day.

Payment for three weeks is required upon starting your first week.

(Additional fees for Lavender Festival and Heritage Days paid to the event organizers.)

\_\_\_\_\_ **Week-to-Week Youth Vendor** - Price for 10' wide booth is \$5 per regular market day.

Students up through high school seniors qualify as youth vendors.

\_\_\_\_\_ **Week-to-Week Prepared Food/Hot Food Vendor** – Price for 10' wide booth is \$20 per regular market day. (Additional fees for Lavender Festival and Heritage Days paid to the event organizers.)

Any week-to-week vendor completing payments for ten weeks will have Market access for the remainder of the season at no additional charge.

Occasional attendance at the regular Angelica Farmers' Market does not grant vendors access to the Lavender Festival or the Heritage Days Festival. Talk to the Market Manager about these events.
